## PRESS RELEASE

### EURO AREA SECURITIES ISSUES STATISTICS: APRIL 2012

*The annual growth rate of the outstanding amount of debt securities issued by euro area residents decreased from 4.8% in March 2012 to 4.4% in April. For the outstanding amount of quoted shares issued by euro area residents, the annual growth rate was 1.4% in April 2012, compared with 1.5% in March.*

New issuance of debt securities by euro area residents totalled EUR 903 billion in April 2012. Redemptions stood at EUR 939 billion and net issues amounted to EUR 1 billion.<sup>1</sup> The annual growth rate of outstanding debt securities issued by euro area residents decreased from 4.8% in March 2012 to 4.4% in April (see Table 1 and Charts 1 and 3).

The annual growth rate of outstanding short-term debt securities increased from 5.7% in March 2012 to 6.5% in April. For long-term debt securities, the annual growth rate decreased from 4.7% in March 2012 to 4.2% in April. The annual growth rate of outstanding fixed rate long-term debt securities decreased from 5.9% in March 2012 to 5.5% in April. The annual rate of change of outstanding variable rate long-term debt securities decreased from 0.6% in March 2012 to -0.2% in April (see Table 1 and Chart 3).

As regards the sectoral breakdown, the annual growth rate of outstanding debt securities issued by non-financial corporations increased from 8.1% in March 2012 to 9.6% in April. For the monetary financial institutions (MFIs) sector, this growth rate decreased from 4.8% in March 2012 to 4.2% in April. The annual growth rate of outstanding debt securities issued by financial corporations other than MFIs increased from 2.0% in March 2012 to 2.8% in April. For the general government, this growth rate decreased from 5.7% in March 2012 to 4.8% in April (see Table 2 and Chart 4).

The annual growth rate of outstanding short-term debt securities issued by MFIs increased from 14.6% in March 2012 to 16.2% in April. The annual growth rate of outstanding long-term debt securities issued by MFIs decreased from 3.5% in March 2012 to 2.7% in April (see Table 2).

Concerning the currency breakdown, the annual growth rate of outstanding euro-denominated debt securities decreased from 4.9% in March 2012 to 4.5% in April. For debt securities in other currencies, this growth rate was 3.8% in April 2012, compared with 3.7% in March (see Table 1).

New issuance of quoted shares by euro area residents totalled EUR 3.1 billion in April 2012. Redemptions came to EUR 0.3 billion and net issues amounted to EUR 2.7 billion. The annual growth rate of the outstanding amount of quoted shares issued by euro area residents (excluding valuation changes) was 1.4% in April 2012, compared with 1.5% in March. The annual growth rate of quoted shares issued by non-financial corporations was 0.2% in April 2012, compared with 0.3% in March. For MFIs, the corresponding growth rate decreased from 11.3% in March 2012 to 10.7% in April. For financial corporations other than MFIs, this growth rate increased from 2.8% in March 2012 to 3.1% in April (see Table 4 and Chart 6).

The market value of the outstanding amount of quoted shares issued by euro area residents totalled EUR 4,099 billion at the end of April 2012. Compared with EUR 4,892 billion at the end of April 2011, this represents an annual decrease of -16.2% in the value of the stock of quoted shares in April 2012, down from -10.4% in March.

*Unless otherwise indicated, data relate to non-seasonally adjusted statistics. In addition to the developments for April 2012, this press release incorporates minor revisions to the data for previous periods. The annual growth rates are based on financial transactions that occur when an institutional unit incurs or redeems liabilities, they are not affected by the impact of any other changes which do not arise from transactions.*

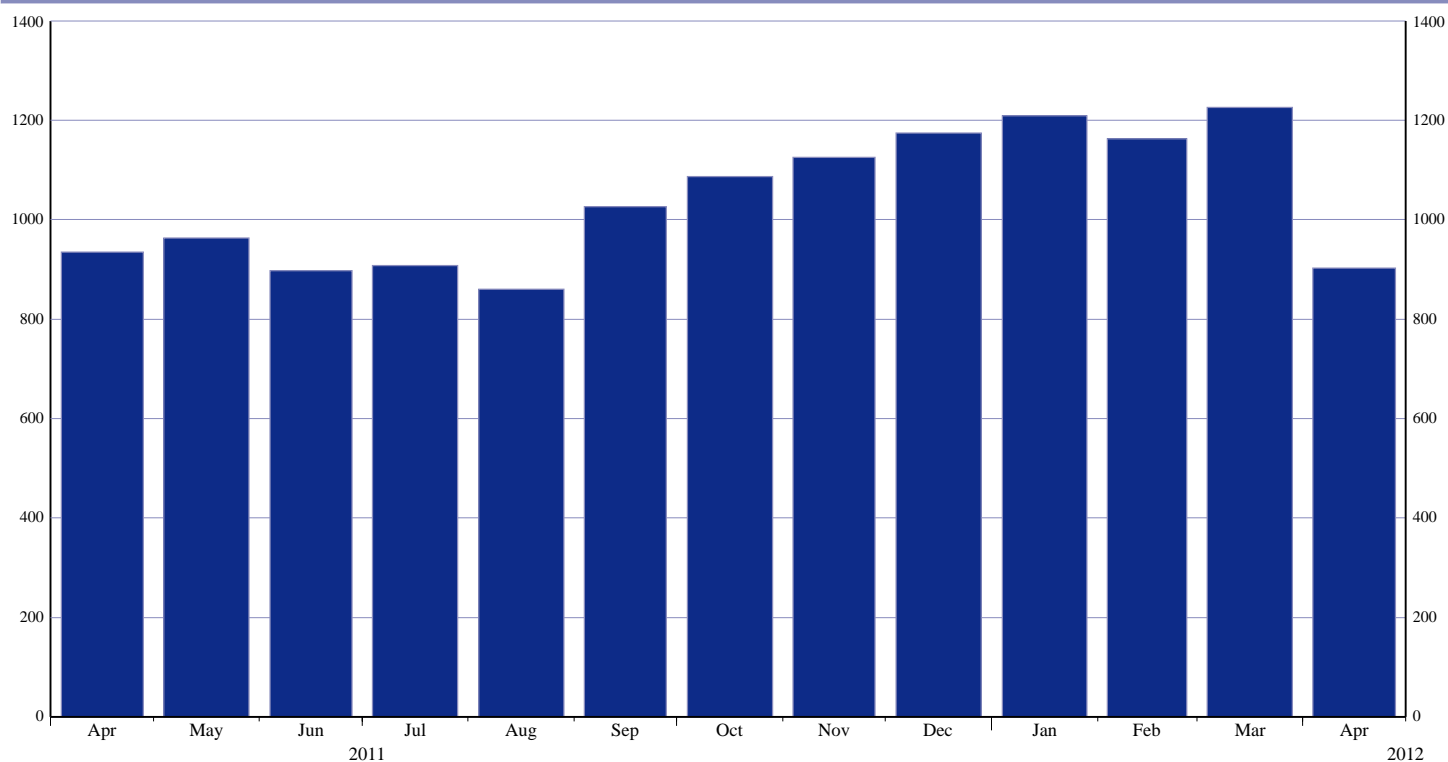

### Chart 1: Total gross issuance of debt securities by euro area residents

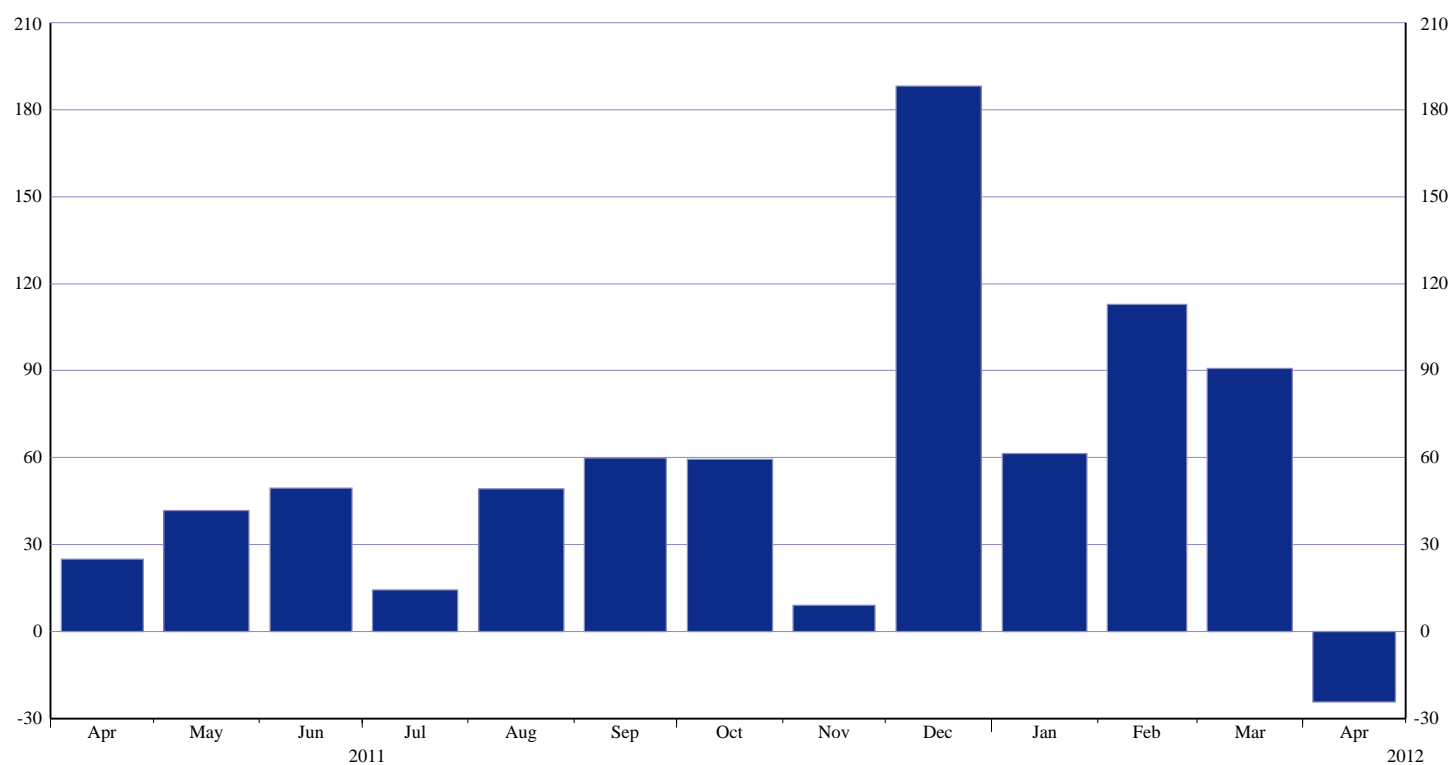
(EUR billions; transactions during the month; nominal values)

### Chart 2: Total net issuance of debt securities by euro area residents

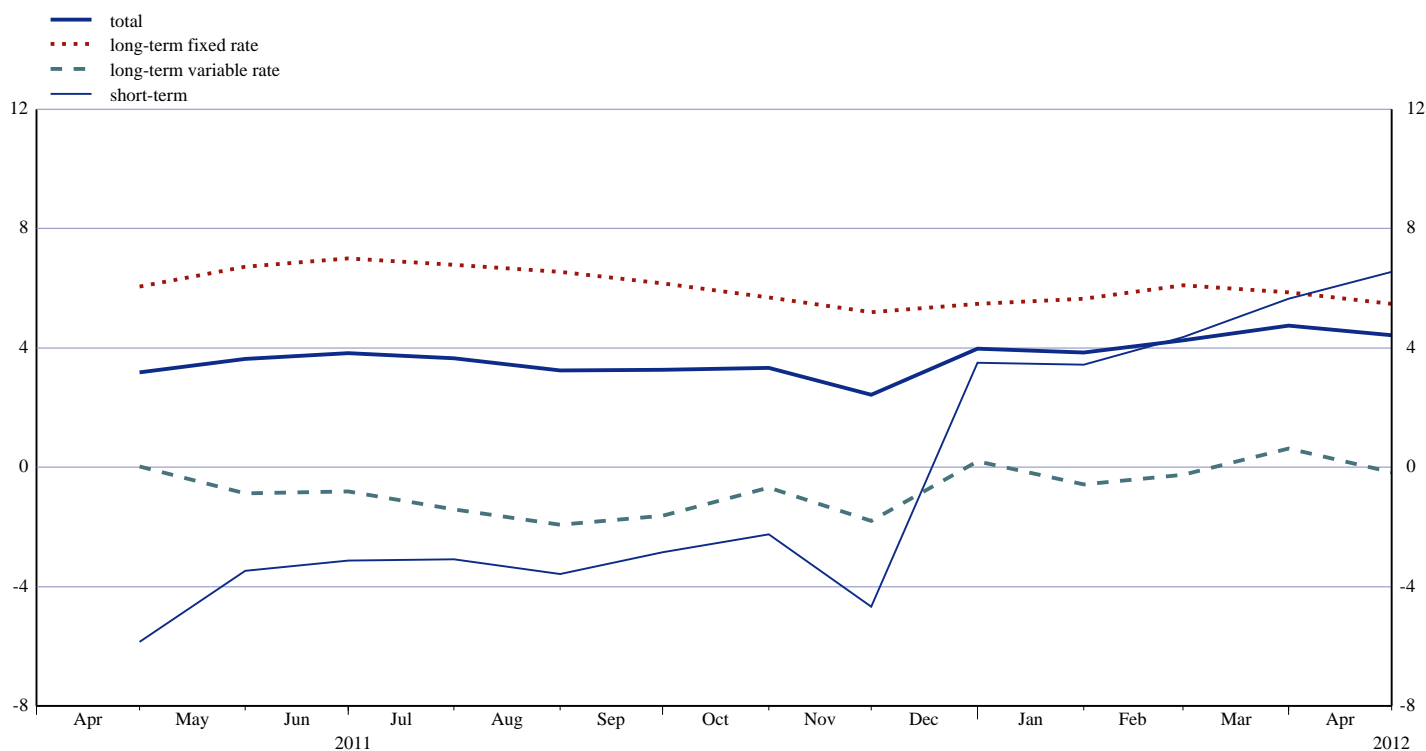
(EUR billions; transactions during the month; nominal values; seasonally adjusted)

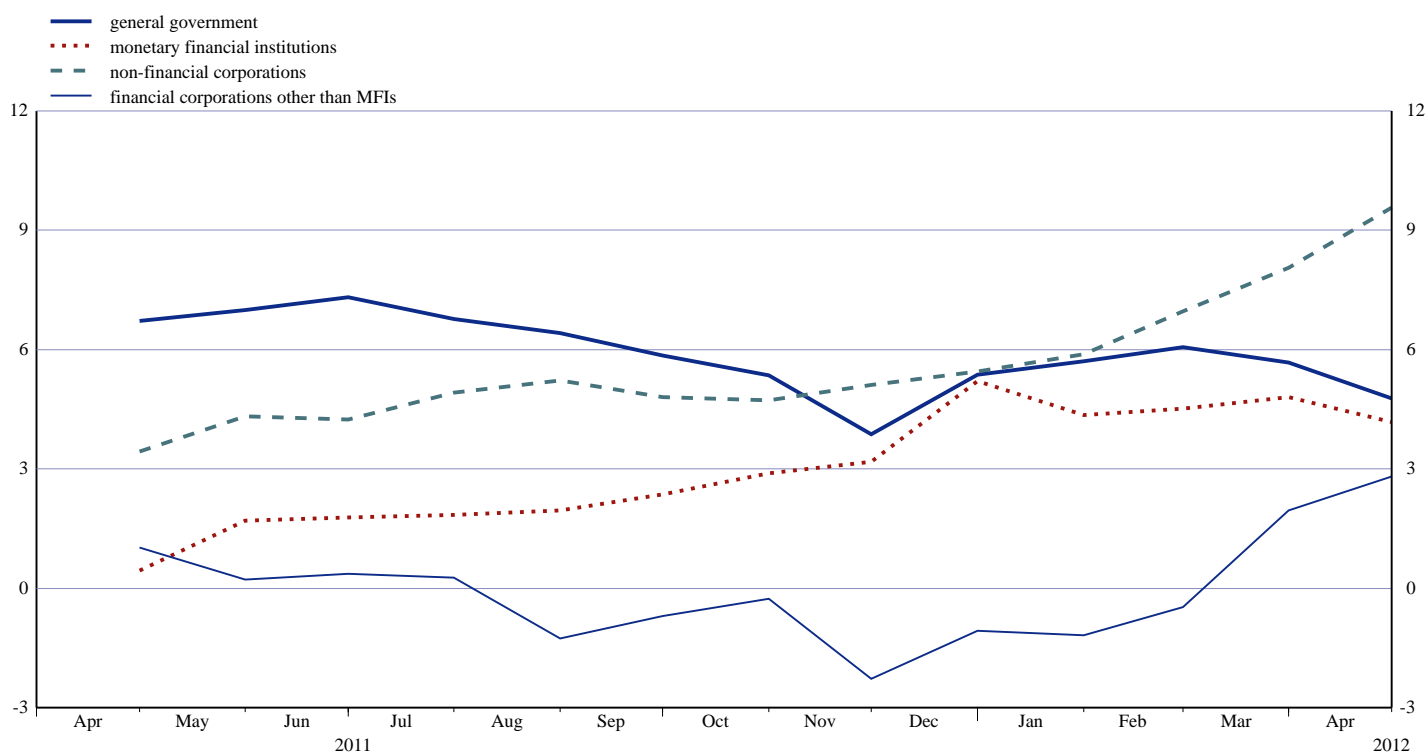

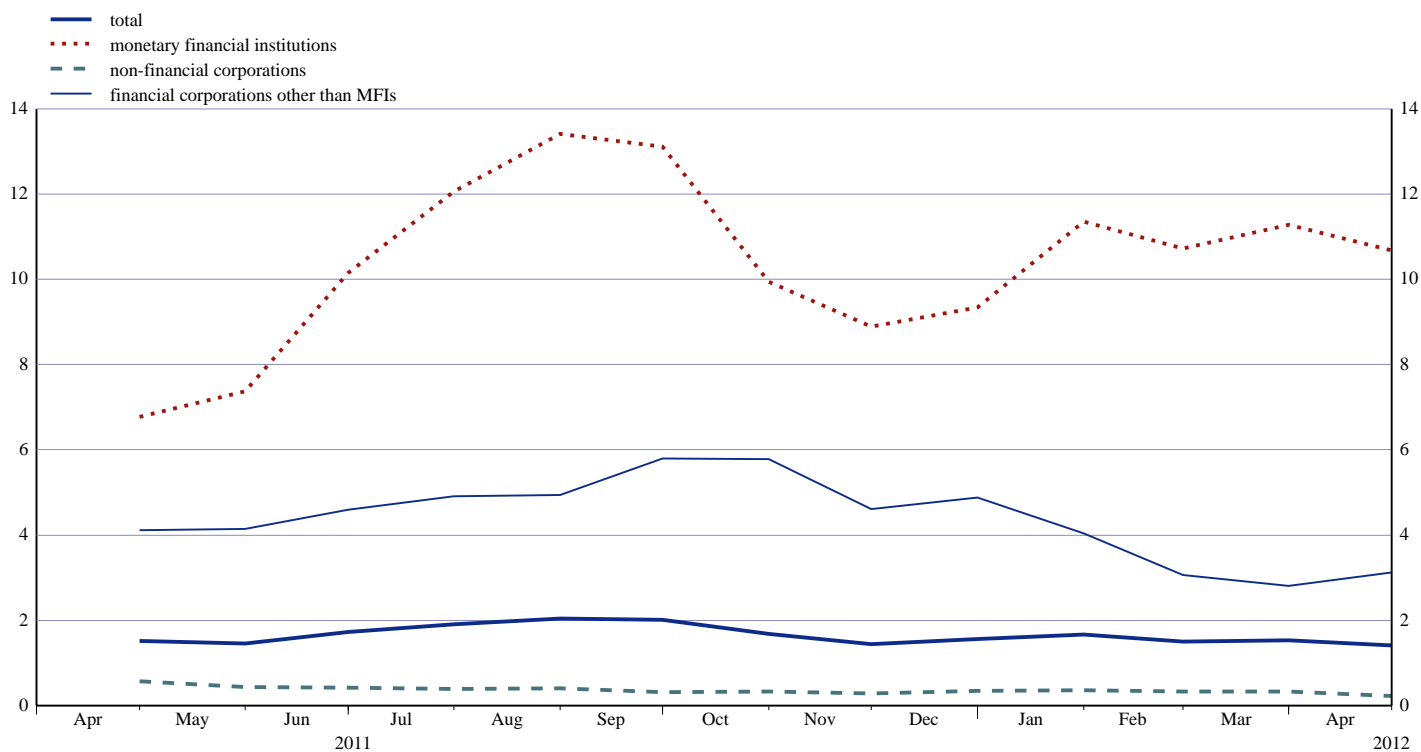
