The policy wording required will be on a 'No Worse' basis when compared to the current contract. All members will be eligible to join without previous medical history being declared or excluded. All participants will be required to provide on-line facilities to both the ECB and the scheme members, with on-line membership and management reporting as well as members on-line claims tracking facilities.
