A price simulator is a device with which you can calculate different costs/fees of services at real time, by putting all the required data into an interactive platform.




What is it for?


The Price Simulator IS NOT neither a requirement nor a suggestion under the provisions of the Code of Conduct on Clearing and Settlement.




Price simulator diagram



- Quality: (*software used, free access*)
- Rapidity: (*in gathering information*)
- Simplicity: (*in using software or website*)

- 4) It does not provide such service directly. It can be found through other linked websites.

- 5) Service provided in French and Dutch only.

- 6) Service provided by updating the website after the survey’s launch.

- 7) The linked pdf file has not been found.





EUROZONE + UK



EU MEMBERSHIP




Price simulator provided by 17 members out of 49




Price simulator provided by 14 members out of 35




