1. Review of market developments

The Group reviewed and discussed the latest trends in financial markets, particularly in FX markets, following the presentation made by Michael Metcalfe, head of macro strategy at State Street.

2. The Sovereign Wealth Funds: implications for financial markets

Manuel Oliveri, currency strategist at UBS, made a presentation on Sovereign Wealth Funds. The presentation focused on the composition and importance of SWFs, the factors behind their growth, the composition of their assets, their impact on financial markets and outlook.

3. Presentation by Quaesta Capital AG

Harald Hild, portfolio manager at Quaesta Capital AG, made a presentation on Foreign Exchange Funds. He elaborated on the different strategies and trading styles of FX funds in particular against the background of volatile markets.
