# EURO AREA INVESTMENT FUND STATISTICS DECEMBER 2003

The total assets of euro area investment funds amounted to EUR 3,174 billion in December 2003, compared with EUR 3,086 billion in September 2003.¹ One year earlier, in December 2002, euro area investment fund assets had been worth EUR 2,861 billion. The increase between September and December 2003 was mainly due to a rise in investment funds' holdings of shares and other equity: from EUR 932 billion in September to EUR 1,034 billion in December.

The asset side of the aggregated balance sheet of euro area investment funds shows that in December 2003 holdings of securities other than shares accounted for 44% of total assets, down from 46% in September (see Chart 1). The second largest item was the holdings of shares and other equity, whose contribution to the balance sheet total of investment funds amounted to 33% in December 2003, up from 30% in the previous quarter. Deposits accounted for 7% of total assets in December 2003, down from 8% in September. The holdings of fund shares and fixed assets stood, respectively, at 8% and 4% of the balance sheet total in December 2003, unchanged from September.

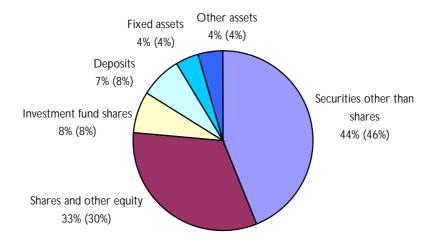
As regards the **breakdown by investment policy**, the share of total assets in bond funds decreased in December 2003 to 34%, down from 37% in September; over the same period, the share in equity funds increased from 21% to 22% and the share in mixed funds increased from 24% to 25% (see Chart 2). The share of real estate funds remained unchanged in December 2003 at 5%.

(September 2003 in brackets)

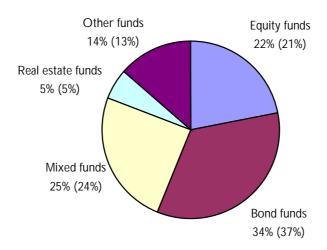
