EURO AREA SECURITIES ISSUES STATISTICS: FEBRUARY 2007

The annual growth rate of the outstanding amount of debt securities issued by euro area residents increased from 8.0% in January 2007 to 8.2% in February. For the outstanding amount of quoted shares issued by euro area residents, the annual growth rate was 1.1% in February 2007, compared with 1.0% in January.

New issuance of **debt securities** by euro area residents totalled EUR 1014.3 billion in February 2007 (see Table 1 and Chart 1). As redemptions came to EUR 897.4 billion, net issues amounted to EUR 116.9 billion (see Table 1). The annual growth rate of outstanding debt securities issued by euro area residents increased from 8.0% in January 2007 to 8.2% in February (see Table 1 and Chart 3).

As regards the sectoral breakdown, the annual growth rate of outstanding debt securities issued by non-financial corporations was 5.3% in February 2007, compared with 5.2% in January (see Table 2 and Chart 4). For the monetary financial institutions (MFIs) sector, this growth rate increased from 10.5% in January 2007 to 10.7% in February. The annual growth rate of outstanding debt securities issued by financial corporations other than MFIs was 27.0% in February 2007, the same as in January. For the general government, this growth rate increased from 2.2% in January 2007 to 2.4% in February.

As regards the maturity breakdown, the annual growth rate of outstanding short-term debt securities was 5.9% in February 2007, compared with 5.8% in January (see Table 1 and Chart 3). For long-term debt securities, the annual growth rate increased from 8.2% in January 2007 to 8.4% in February. The annual growth rate of outstanding fixed rate long-term debt securities increased from 5.2% in January 2007 to 5.5% in February. The annual growth rate of outstanding variable rate long-term debt securities decreased from 15.1% in January 2007 to 14.9% in February.

Concerning the currency breakdown, the annual growth rate of outstanding euro-denominated debt securities was 7.4% in February 2007, the same as in January. For debt securities in other currencies, this growth rate increased from 13.2% in January 2007 to 14.3% in February (see Table 1).

The seasonally adjusted three-month annualised growth rate of outstanding debt securities issued by euro area residents decreased from 8.1% in January 2007 to 7.6% in February (see Table 3 and Chart 5).

New issuance of **quoted shares** by euro area residents totalled EUR 8.4 billion in February 2007 (see Table 4). As redemptions came to EUR 2.1 billion, net issues amounted to EUR 6.3 billion. The annual growth rate of the outstanding amount of quoted shares issued by euro area residents (excluding

valuation changes) was 1.1% in February 2007, compared with 1.0% in January (see Table 4 and Chart 6). The annual growth rate of quoted shares issued by non-financial corporations was 0.8% in February 2007, the same as in January. For monetary financial institutions, it increased from 2.1% in January 2007 to 2.5% in February. For financial corporations other than MFIs, this growth rate was 0.9% in February 2007, compared with 0.8% in January.

The outstanding amount of quoted shares issued by euro area residents totalled EUR 6,228 billion at the end of February 2007. Compared with EUR 5,437 billion at the end of February 2006, this represents an annual increase of 14.6% in the value of the stock of quoted shares in February 2007, down from 19.1% in January, due to market valuation changes.

Unless specified otherwise, data relate to non-seasonally adjusted statistics and the current composition of the euro area. In addition to the developments for February 2007, this press release may incorporate minor revisions to the data for previous periods. A complete set of updated securities issues statistics is available on the "Money, banking and financial markets" pages of the "Statistics" section of the ECB's website (http://www.ecb.int/stats/money/securities/html/index.en.html). These data, as well as the euro area data according to the composition of the euro area at the time of the reference period, can be downloaded using the ECB's Statistical Data Warehouse (SDW). The results up to February 2007 will also be published in the May 2007 issues of the ECB's Monthly Bulletin and Statistics Pocket Book. The next press release on the euro area securities issues will be published on 23 May 2007.



(EUR billions; transactions during the month; nominal values; seasonally adjusted)





Chart 3: Annual growth rates of debt securities issued by euro area residents, by original maturity (percentage changes)

Chart 4: Annual growth rates of debt securities issued by euro area residents, by sector (percentage changes)







Chart 5: Growth rates of debt securities issued by euro area residents, seasonally adjusted $(percentage\ changes)$


