CONSOLIDATED FINANCIAL STATEMENT OF THE EUROSYSTEM as at 3 March 2000

I. Items not related to monetary policy operations

In the week ending 3 March 2000 the net position of the Eurosystem in foreign currency (asset items 2 and 3 minus liability items 6, 7 and 8) decreased by EUR 0.1 billion to EUR 253.3 billion. The gold position of the Eurosystem remained unchanged.

The holdings by the Eurosystem of marketable securities of euro area residents denominated in euro (asset item 6) increased by EUR 0.3 billion to EUR 24.9 billion. Banknotes in circulation (liability item 1) increased by EUR 4.7 billion to EUR 349.7 billion. Liabilities to general government (liability item 4.1) decreased by EUR 5.6 billion to EUR 51.7 billion.

II. Items related to monetary policy operations

The Eurosystem's net lending to its counterparties in the financial sector (asset item 5 minus liability items 2.2, 2.3, 2.4, 2.5 and 3) increased by EUR 25.1 billion to EUR 210.4 billion. On Wednesday, I March 2000, a **main refinancing operation** of EUR 59 billion matured and a new one of EUR 89 billion was settled. On Thursday, 2 March 2000, a **longer-term**

refinancing operation of EUR 25 billion matured and a new one of EUR 20 billion was settled.

Recourse to the **marginal lending facility** (asset item 5.5) increased to EUR 0.4 billion, while recourse to the **deposit facility** (liability item 2.2) was negligible.

III. Current accounts of the euro area financial sector

As a result of all transactions, the **current account** position of counterparties with the Eurosystem (liability item 2.1) increased by EUR 27.4 billion to EUR 122.8 billion.
