# CONSOLIDATED FINANCIAL STATEMENT OF THE EUROSYSTEM as at 18 July 2003

#### I. Items not related to monetary policy operations

In the week ending 18 July 2003 the net position of the Eurosystem in foreign currency (asset items 2 and 3 minus liability items 7, 8 and 9) decreased by EUR 1.1 billion to EUR 197.5 billion.

The holdings by the Eurosystem of marketable securities of euro area residents denominated in euro (asset item 7) increased by EUR 0.1 billion to EUR 44.5 billion. Banknotes in circulation (liability item 1) rose by EUR 0.7 billion to EUR 386.9 billion. Liabilities to general government (liability item 5.1) decreased by EUR 6.3 billion to EUR 40.4 billion.

#### II. Items related to monetary policy operations

The Eurosystem's net lending to credit institutions (asset item 5 minus liability items 2.2, 2.3, 2.4, 2.5 and 4) decreased by EUR I billion to EUR 242 billion. On Wednesday, 16 July 2003, two main refinancing operations of EUR 56 billion and EUR 43 billion respectively matured and a new one of EUR 98 billion was settled.

Recourse to both the **marginal lending facility** (asset item 5.5) and the **deposit facility** (liability item 2.2) was virtually nil, which was approximately the same as in the preceding week.

#### III. Current accounts of euro area credit institutions

As a result of all transactions, the **current account** position of credit institutions with the Eurosystem (liability item 2.1) increased by EUR 2.9 billion to EUR 133.7 billion.
