CONSOLIDATED FINANCIAL STATEMENT OF THE EUROSYSTEM as at 23 January 2004

I. Items not related to monetary policy operations

In the week ending 23 January 2004 the net position of the Eurosystem in foreign currency (asset items 2 and 3 minus liability items 7, 8 and 9) decreased by EUR 0.4 billion to EUR 175.6 billion on account of customer and portfolio transactions.

The holdings by the Eurosystem of marketable securities of euro area residents denominated in euro (asset item 7) increased by EUR 0.9 billion to EUR 63.1 billion. Banknotes in circulation (liability item 1) decreased by EUR 4 billion to EUR 415.1 billion. Liabilities to general government (liability item 5.1) rose by EUR 14.7 billion to EUR 51.7 billion.

II. Items related to monetary policy operations

The Eurosystem's net lending to credit institutions (asset item 5 minus liability items 2.2, 2.3, 2.4, 2.5 and 4) increased by EUR 10.2 billion to EUR 278.2 billion. On Wednesday, 21 January 2004, a main refinancing operation of EUR 80 billion matured and a new one of EUR 85 billion was settled.

Recourse to the **marginal lending facility** (asset item 5.5) was EUR 5.6 billion (compared with virtually nil in the previous week), while recourse to the **deposit facility** (liability item 2.2) was EUR 0.4 billion (compared with EUR 0.1 billion in the preceding week).

III. Current accounts of euro area credit institutions

As a result of all transactions, the **current account** position of credit institutions with the Eurosystem (liability item 2.1) decreased by EUR 0.7 billion to EUR 134.3 billion.
