- (3) The monthly monitoring will be prepared by the Foreign Exchange Policy Sub-Committee (Monitoring Group) and will be based on the "Monitoring Charts", "Effective Exchange Rate Charts", "Concertation Tables" and "Monthly Statistical Series" which will be drawn up by the Secretariat and will be ready for the Governors in Basle.
- (4) The draft report prepared by the Secretariat and finalised by the Concertation Group will be circulated to the Governors in Basle.
- (5) Under this item, the Committee will consider the Work Programmes submitted by the Foreign Exchange Policy Sub-Committee (circulated on 31st July 1992), the Monetary Policy Sub-Committee and the Banking Supervisory Sub-Committee, as well as by the Working Groups on Statistics, Information Systems, Accounting Issues and EC Payment Systems, all of which are expected to be circulated soon.
