#### DECISION OF THE EUROPEAN CENTRAL BANK

#### of 7 October 2014

# amending Decision ECB/2008/NP5 on the delegation of powers regarding the Annual Salary and Bonus Review

#### (ECB/2014/NP20)

### THE EXECUTIVE BOARD OF THE EUROPEAN CENTRAL BANK,

Having regard to the Statute of the European System of Central Banks and of the European Central Bank, and in particular Article 11.6 thereof,

Having regard to the Rules of Procedure of the European Central Bank, and in particular Article 21.1 and 21.3 thereof,

Having regard to the Conditions of Employment for Staff of the European Central Bank, and in particular Articles 5 and 6 of Annex I thereto,

Having regard to the Rules of Procedure of the Executive Board of the European Central Bank, and in particular Article 5.2 and 5.4 thereof,

Whereas it is necessary to amend Decision ECB/2008/NP5 of 6 August 2008, as further amended by Decision ECB/2011/NP18, delegating the powers established in Article 5 of Annex I - Salary Structure to the Conditions of Employment in the light of the changes to the organisational structure of the ECB and in particular the establishment of the SSM,

HAS DECIDED AS FOLLOWS:

#### Article 1

## **Delegated powers**

Article 1(1) of Decision ECB/2008/NP5 is replaced by the following:

'1. The powers established in Article 5 of Annex I - Salary Structure to the Conditions of Employment shall be delegated jointly to the Chair of the Supervisory Board and the Vice-Chair of the Supervisory Board in respect to the Directors General Micro Prudential Supervision I, II, III and IV and the Director Secretariat to the Supervisory Board.

### **ECB-RESTRICTED**

2. The powers established in Article 5 of Annex I - Salary Structure to the Conditions of Employment shall be delegated to the area head of the business area in which the member of staff is employed as outlined in the Annex to this Decision.'

### Article 2

### Amendment to the Annex

The Annex to this Decision shall replace the Annex to Decision ECB/2008/NP5

### Article 3

### **Entry into force**

This Decision, amending Decision ECB/2008/NP5 on the delegation of powers regarding the Annual Salary and Bonus Review, shall enter into force on 1 November 2014.
