# DECISION OF THE EUROPEAN CENTRAL BANK of 18 October 2016 amending Decision ECB/2008/NP5 on the delegation of powers regarding the Annual Salary and Bonus Review (ECB/2016/NP36)

THE EXECUTIVE BOARD OF THE EUROPEAN CENTRAL BANK,

Having regard to the Statute of the European System of Central Banks and of the European Central Bank, and in particular Articles 11.6, 12.3 and 36.1 thereof,

Having regard to the Rules of Procedure of the European Central Bank, and in particular Articles 21.1 and 21.3 thereof,

Having regard to the Conditions of Employment for Staff of the European Central Bank, and in particular Article 9(a) thereof, and Articles 5 and 6 of Annex I thereof,

Whereas:

- (1) The second paragraph of Article 1(1) of Decision ECB/2008/NP5, as further amended by Decisions ECB/2011/NP18 and ECB/2014/NP20, delegates the powers established in Article 5 of Annex I Salary Structure to the Conditions of Employment to the area head of the business area in which the member of staff is employed.
- (2) It is necessary to amend Decision ECB/2008/NP5 delegating the powers established in Article 5 of Annex I – Salary Structure to the Conditions of Employment for Staff of the European Central Bank in light of the recent changes to the ECB's organisational structure,

HAS DECIDED AS FOLLOWS:

The Annex is replaced by the Annex to this Decision.

This Decision shall enter into force on 1 November 2016.
