Furthermore, it organises the Cultural Days of the European Central Bank, which bring the cultural diversity and wealth of the EU Member States to the people of the Rhine-Main region, as well as to visitors from Europe and the whole world. The Cultural Days are held annually and showcase, in a period of 3–4 weeks, the culture of 1 EU Member State via a series of concerts, readings, dance performances, films, lectures, exhibitions and other events.
