The maximum number of points achievable per criterion is equivalent to the percentage weightings allocated to the selection criteria. The selection criteria shall be assessed one by one against the ECB's requirements for each lot and evaluated on the basis of a scoring system from 0 to 5 points. Applications which do not obtain at least 3 points (out of a maximum of 5) for each of the criteria shall be considered to be of an unacceptably low quality, and the candidate's applications shall be rejected and not further evaluated. To pass criteria (a) and obtain 3 points the candidate shall have performed 3 similar assignments during the preceding 3 years (2010–2012) which are comparable in terms of scope, size and complexity with the services requested by the ECB for the relevant lot.
