

## MARKET SURVEY FOR ROMANIAN LAWYER-LINGUIST SERVICES: LEGAL TRANSLATION AND LEGAL ADVICE ON ROMANIAN LAW

(Reference: PRO-000086)

**I. Scope and aim of the market survey** The Legislation Division of the European Central Bank (ECB) is launching a market survey to identify freelance lawyer-linguists or agencies that can provide lawyer-linguist services (hereinafter 'suppliers') with **Romanian** as their main language.

The aim of this survey is to identify skilled and experienced suppliers who would be willing and able to provide legal translation and legal advice services to the ECB. The survey is being carried out for information purposes only and does not form part of a formal procurement procedure.

### II. Background information

Business area Directorate General Legal Services

Division Legislation Division

Function The Legislation Division is responsible for preparing the legal acts of the European Central Bank (ECB) in the official EU languages, for editing and reviewing legal texts for legal, linguistic and terminological consistency, for translating legal documentation, including documentation relating to court cases, into the official EU languages and for maintaining a legal terminology database.

The Division also provides expertise in the national legal systems of all EU Member States and coordinates the preparation of the ECB's opinions on draft national legislative provisions.

Required skills The main tasks of suppliers will be:  
(a) to translate legal texts from English into Romanian, and  
(b) to provide legal advice on Romanian law.

Suppliers will be expected to carry out the main tasks remotely or in-house (e.g. to cover holiday periods and periods of heavy workload).

Suppliers work on the basis of framework contracts, which are awarded for a period of up to four years. Although framework contracts do not establish an obligation on the part of the ECB to purchase services from the contractors, they enable the ECB to occasionally issue orders for lawyer-linguist services as described above.

Suppliers with **Romanian** as their main language normally have the following professional experience and qualifications:

- mastery-level command of Romanian (Europass C2 standard) as their main language and mastery-level command of English (Europass C2 standard);
- a degree in Romanian law from a Romanian university, or a degree in law from a

university outside Romania which has been recognised in Romania as equivalent;

- professional experience of two years or more in translating legal texts from English into Romanian, either self-employed or as an employee, full-time or part-time;
- a sound background knowledge of EU law and financial and economic affairs;
- advanced PC skills and a very good knowledge of standard MS Office applications.

In addition, the ECB considers the following qualifications and experience to be an advantage:

- a Bachelor's or Master's degree-level diploma in translation;
- current certification as a Court translator from English into Romanian;
- professional experience of two years or more in translating and revising banking and/or financial texts from **English into Romanian**, either self-employed or as an employee, full-time or part-time;
- intermediate-level command (Europass B2 standard) or higher of a third official EU language, in addition to Romanian and English;
- professional experience using translation memory software and a terminology management package such as Studio 2014/TRADOS Translators' Workbench and TRADOS MultiTerm;
- a postgraduate qualification in banking and/or financial law;
- familiarity with the ECB, other EU institutions, international organisations, Banca Națională a României and the financial sector.

- Suppliers should also expressly state their interest and availability to provide lawyer-linguist services to the ECB as described above: (a) remotely, (b) for in-house work assignments at the ECB's offices in Frankfurt am Main, or (c) both remotely and in-house.
- Suppliers who are companies (e.g. agencies) should submit the CVs of named individual lawyer-linguists who have the required skills, can provide lawyer-linguist services to the ECB and are either their employees or consultants.
- The information and/or CVs submitted should be as complete and substantiated as possible (e.g. including the relevant contact persons and/or names of the institutions to support work experience and/or qualifications).
