Description of requested change:

A detailed analysis has been performed by 4CB to highlight gaps between TIPS and SCT Inst Xml Schema Definition for compliance with the reference Implementation Guidelines specifications document.

The result has been present in the TIPS Contact Group #7 and a 2 weeks written procedure has been agreed to validate the analysis and confirm the way forward about gaps requiring a change in TIPS XML Schema Definition resource files.
