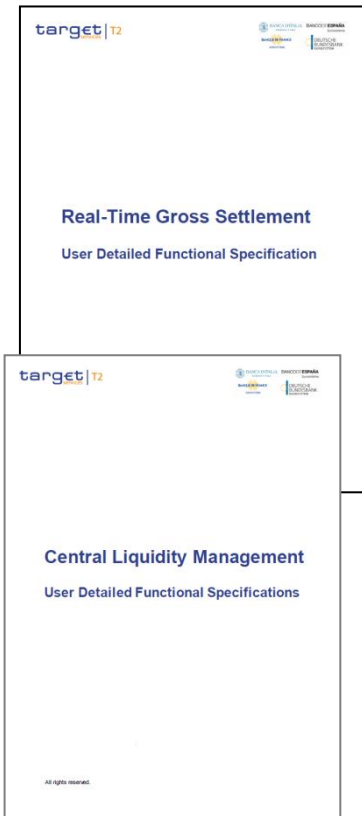

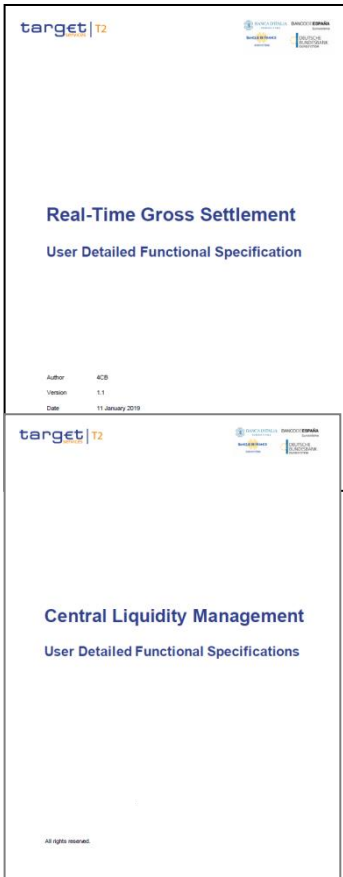

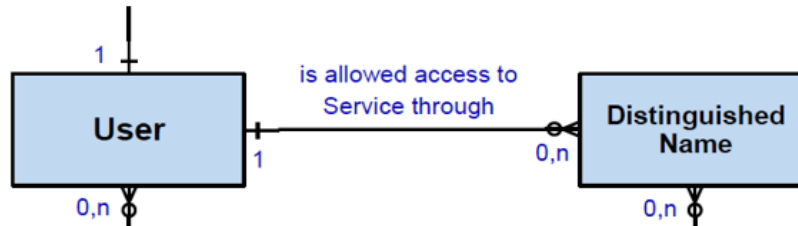


- **Addendum document should reflect topics from UDFS Version 2.1 (Part III) which should be more detailed and help customer during their implementation process**
- **No additional UDFS Version but a kind of errata document**
- **Standalone document with new examples published before UDFS 2.2**
- **Main focus of the addendum is on Part III of CLM/RTGS UDFS e.g.:**
  - Correction of inconsistencies
  - Adding missing ASI messages
  - Message examples to be improved (more business oriented)
  - Improved consistency of the business rules
  - Camt.050 Harmonisation/Alignment dossier
- **Timeline for Addendum document to be agreed between 4CB/ECB will follow shortly**



- UDFS Version 2.2 is shared before CB testing phase starts
- Version 2.2 will include CR assessments approved after UDFS 2.1 publication
- CR detailed assessments launched after publication of UDFS 2.1 will include concrete and marked wording of the affected UDFS chapters within section „Proposed wording of the Change request:

Moreover in chapter 9.1.3 of the Common Component URD the cardinality for "User" is to be changed from "1" to "1..n".



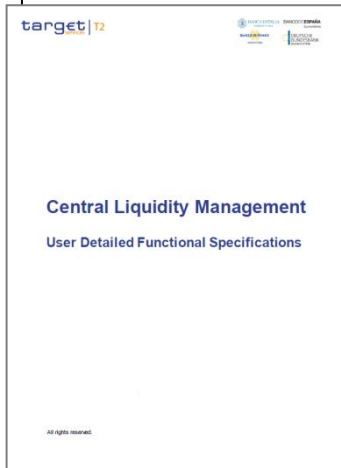
CLM UDFS:  
chapter 2.2 Authentication and authorisation process in CLM:

CLM then carries out the authorisation of the sender at application level. The DN that is used to sign the A2A message is linked to **one at least one** user or application **since it is possible to use one DN by more than one user**. The user may have one or many roles. The authorisation of the request is checked against the role's access privileges.
