Amount field harmonisation

- Currently there are several amount field definitions set up in the CSLD message portfolio
 - 14 digits with 2 decimals places
 - 18 digits with 2 decimal places
 - 14 digits with 5 decimal places
 - 18 digits with 5 decimal places
- The current situation results in consistency and interoperability issues
 - Large amounts that are instructed/reported in amount fields with 18 digits and 2 decimal places (e.g. central banks amounts) may be truncated when using messages with amounts defined with 14 digits and 2 decimal places
 - CLM and RTGS only supports two decimal places for amount fields
 - The same message will have multiple schemas

Amount field harmonisation

- The proposal is to harmonise all amount field definitions in the CSLD message portfolio to 18 digits with 2 decimal places for all CLM and RTGS messages
 - Exceptions:
 - ASTI and ASIS pain.998 messages will keep the defined 16 fraction digits with 2 decimal places
 - Instructed amount field and charges amount field will be 18 digit with 5 decimal places
 - camt.077 BillingReport message as URD requires deeper granularity of decimal places
- The harmonisation would affect the following messages that CRDM uses for both T2-T2S Consolidation and T2S
 - acmt.007
 - acmt.015
 - camt.024
 - camt.070

Messages not part of this list are not subject to the amount field alignment , e.g. no amount field present.
