**Reason for change and expected benefits/business motivation:**

In the current CRDM software, an Ancillary system (AS) can see the account numbers of the accounts included in a Settlement Bank Account Group (SBAG) of which it is a leader.

It cannot see the account BICs of these accounts. This is problematic since the AS needs the account BIC in order to build pain.998 messages.

This functionality is available in A2A in the current TARGET2 through GetASSettBank/ReturnASSettBank messages and it should be reinstated through the following changes.

**Description of requested change:**

1. U2A display of SBAG:

A user of the AS party defined as leader of the SBAG should be able to see in CRDM all the account BICs and account numbers it needs to build the pain.998 messages for the configured AS procedures:

More precisely, the SBAG leader can see the following information in CRDM for the accounts included in the SBAG:

	RTGS CB Account	RTGS DCA	RTGS Sub Accounts

\*Account BIC that is existing and active for it in the moment of the query; In the exceptional case where no account BIC is defined (through a direct AAU) in the moment of the query for an RTGS DCA or RTGS CB account: blank<sup>1</sup>

Note: No update of the AS Liquidity Overview RTGS screen is required.

## 2. U2A creation/update of SBAG:

The current software can lead to a misleading situation. For example: a CB user can log in CRDM on 16 February at 9am and add an account to an SBAG with "valid from" date (date of the assignment of the account to the SBAG) = 16 February. Since the SBAG will not be propagated from CRDM to RTGS until the evening of 16 February, RTGS will only "see" the new account in the SBAG from business date equal to 17 February.

If the SBAG leader queries/consults CRDM at 1pm on 16 February, it will think the account is already in the SBAG and use it in a pain.998 on 16 February. This will be wrong as RTGS does not know yet that the account will be included in the SBAG on the next business day.

The proposed solution to this is to prevent the user to enter valid "from date" equal to the current business date.

This would be done updating CRDM business rules DRCJ012, DRCJ013, DRUJ013 and DRJU014. The updates will have the same impact on the other CRDM groups (Account Monitoring Group, Liquidity Transfer Group, Banking Group, Billing Group), but this is also an improvement: the "valid from" dates in CRDM would match precisely the actual "valid from" dates in T2.

Note: this change will be limited to "Data aggregations", i.e. to the validity dates of the *assignment* of an account/party to an SBAG, Account Monitoring Group, Liquidity Transfer Group, Banking Group, Billing Group. There are no plans to perform a similar change for the validity dates of objects like accounts themselves, parties, standing orders etc. which would be a much bigger undertaking with large impacts.

## 3. A2A Query:

The AS leader should be able to query the above SBAG data from CRDM in A2A mode. Since the AS leader can only be the leader of one SBAG, there is no need for criteria in the query message, i.e. the party BIC of the AS should be enough for CRDM to know which SBAG data to send back. All SBAG data should be included in the A2A response (including the accounts BICs/account numbers in the table above, and the "valid from"/"valid to" dates).

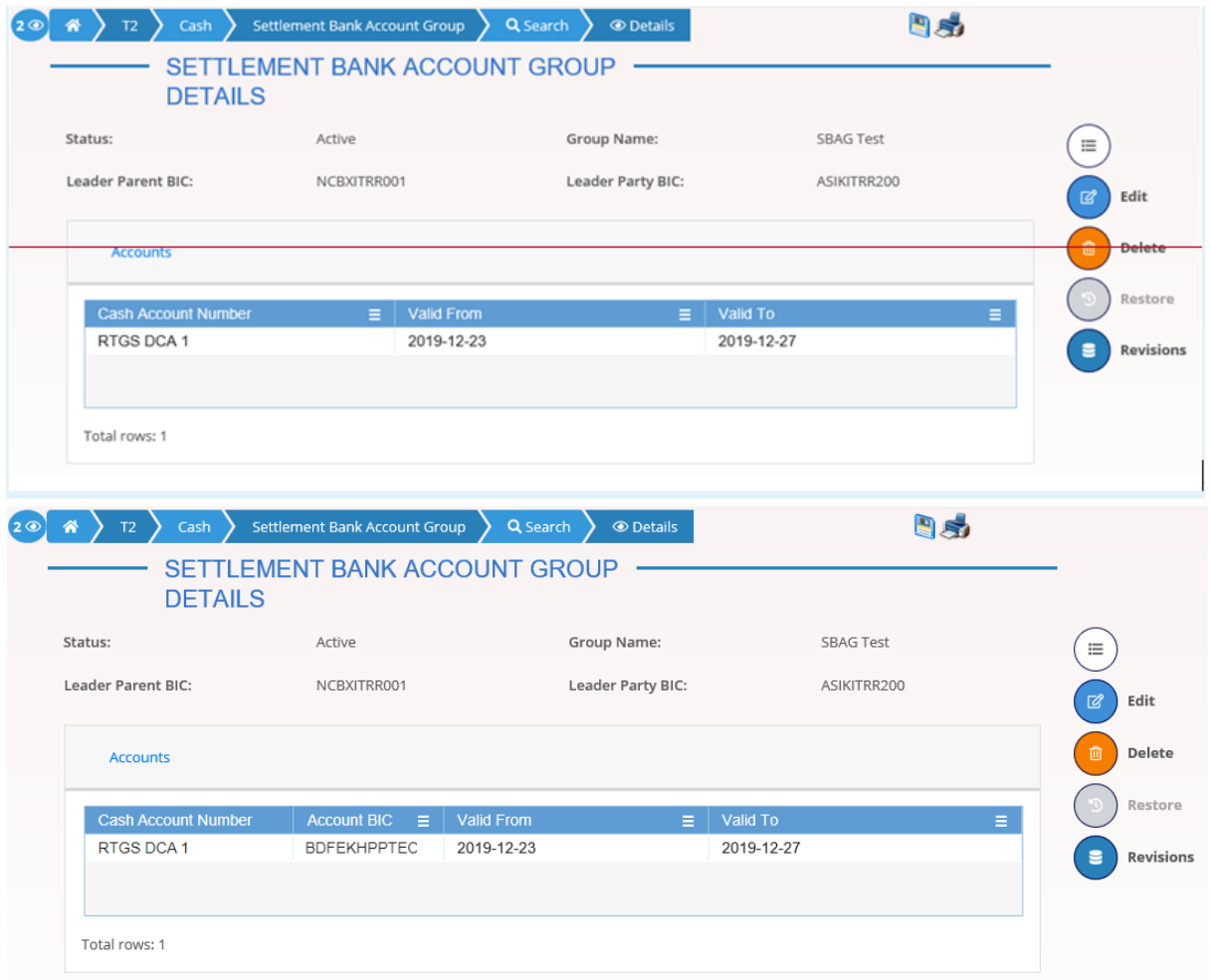


Illustration 96: Settlement Bank Account Group – details screen
