# Business Rules in the ECMS

July 2021

## Introduction

When the ECMS processes instructions sent to the ECMS, business rules are used to perform different validations. This document provides counterparties, CSDs and TPAs with a comprehensive list of the business rules in the ECMS and the corresponding reply text fields that may be sent to the sender of the message or file. It should be viewed in combination with the [ECMS message usage guide](#) and the [Status codes in the ECMS](#).

Description of the columns in the table:

- The first column “File/ Message” gives the short name of the messages sent by the sender to the ECMS;
- Column “Id” gives the code of the business rule;
- Column “Description” explains the business rule to the reader of this document. It is not part of the reply message;
- Column “Checked field in the Incoming Message” identifies the field to which the business rule applies;
- Column “Reply message” gives the short name of the reply message sent to the sender. A value of N/A means that no message reply is sent to the sender;
- Column “Reply field text sent by ECMS” gives the text of the business rule that is communicated to the sender in the reply message;
- Column “Reason code” provides the reason code associated to the business rule;
- Column “Automatic Rejection” indicates whether the ECMS rejects the message automatically.

Checks on messages at access right and interface level are included in the table below (please see Id codes beginning with AARR and INTF).

Validation errors for the messages sent by the sender are also displayed in the ECMS GUI.
