Reason for change / expected benefits / business case:

T2S currently counts for Billing, following the requirement of the Service Items in UDFS to charge each and every Intra Position movement during the billing period with no exceptions; all Intra-Position movements including the T2S generated ones related to auto-collateralisation.

Further clarification has highlighted that T2S-generated Intra-Position movements related to auto-collateralisation, relevant for the Pledge-sub scenario, should bear a zero price while Intra-Position movements sent by T2S Actors and the T2S-generated ones not depending from auto-collateralisation should be counted for billing.

Description of Request:

A clarification of the description of Service Items related to auto-collateralisation shall be performed in order to describe the expected behaviour.

In details, Intra-Position movements' description shall be amended in order to highlight that the items stemming from auto-collateralisation process must not be counted.

For the sake of completeness, the description of the DVP, DWP, FOP, PFOD and Account Allocations Service Items should be improved highlighting that all the Settlement Instructions stemming from auto-collateralisation process are not charged.
