# Meeting of the T2S Change Review Group (CRG)

09 November 2021, from 10:00 to 16:00 CET (held remotely)

# Introductory remarks and approval of the agenda

#### Outcome

The CRG chairperson, Karen Birkel, welcomed the participants and introduced the meeting, held remotely due to COVID-19 precautionary measures.

The CRG members approved the agenda of the meeting.

The CRG members were informed that the CSG Task Force on T2S Recovery would raise several change requests on this topic. As this topic is handled directly at Steering Level, the CRs will be detailed assessed based on a CSG resolution, and the detailed assessments will be made available for CRG review once available i.e. in the first quarter of 2022. At the same time, the CSG is expected to withdraw the previously discussed CR on this topic, CR-711<sup>1</sup>.

The CRG members agreed to update CR-705 to reference several changes to message schemas which were described with CR-704 (allocated to T2S R5.0, June 2021) but become applicable in PROD, for T2S users, with R6.0 (June 2022).

Furthermore, the CRG members took note that 4CB would provide a cover letter to summarise the wording updates proposed to reflect CR-705 in the T2S Scope Defining Documents.

The CRG members confirmed their earlier recommendation to the PMG to implement CR-706 in R6.0.

Furthermore, the CRG members took note that 4CB would provide a cover letter to summarise the wording updates proposed to reflect CR-706 in the T2S Scope Defining Documents.

# T2S-0770-URD (Dynamic allocation of processing priority to massive concurrent settlement attempts and optimisation limit)

The CRG members took note of the outcome of recent interactions between the 4CB, the ECB and interested CRG members on CR-770. The CRG agreed with the proposed way forward i.e. for 4CB to withdraw CR-770 and create a new CR with design enhancements supported by CRG members. Specifically, following the preference of CRG members, the new CR will optimise the way CORP transactions are processed (i.e. constitution of collections and sorting method) by the T2S Settlement module.

The CRG members took note that CR-772 was raised to document the T2S impacts of the T2 change request CSLD-CR-82. The CRG members considered CR-772 to be stable and agreed that its preliminary and/or detailed assessment should start only when such an assessment is launched for CSLD-CR-82.

# New CR on SAC ceiling

The CRG members took note that a CR would be raised by the 4CB following OMG discussions on the securities account ceiling. The CRG recommendation to the Steering Level will be sought via written procedure once the CR is available. The new CR will follow a fast-track procedure as it is intended to cover the period from January 2022 until June 2023.

The CRG members took note that the requirements of CR-444 would be addressed by the introduction of ESMIG for T2S in R6.0, as ESMIG NSPs must offer the possibility to store certificates in a remote Hardware Security Module maintained by the NSP, rather than on a USB token / SmartCard held by the user. Accordingly, the CRG members agreed to convert CR-444 into an editorial CR describing editorial changes to the Business Functionality Document (BFD).

The CRG members recommended CR-444 for authorisation by the T2S Steering Level and for approval of the inclusion of the underlying editorial updates in the T2S SDDs for R6.0.

CRG members took note of a slight modification of the behaviour of the report configuration screens, introduced by the T2-T2S Consolidation project, i.e. BIC fields will be pre-filled to reduce the risk of erroneous user input. CRG members had no outstanding questions on the note, which is also the background of item 1 of the editorial CR-773.

The CRG members confirmed the CR ranking prepared by the ECB team based on the business values provided by CRG members.

# Release Scoping presentation for R7.0

The CRG members took note that the 4CB would propose to the PMG to distribute CR candidates for R7.0 into two batches of detailed assessments (starting in November 2021 and early 2022, respectively). Package 1 would include

CR-551, CR-740, CR-764 and CR-766<sup>4</sup>, which would be detailed assessed in parallel with the planned Recovery CRs, while Package 2 would include CR-525, CR-720, CR-756, CR-763 and CR-769<sup>5</sup>.

A CRG member pointed out that one highly-ranked change request, CR-638<sup>6</sup> (#6/23) was not included in the proposed packages. The reason for non-inclusion being to avoid potential impacts on the Eurosystem Collateral Management System (ECMS) project, the CRG requested that this discrepancy between the CRG ranking and the envisaged contents of R7.0 be highlighted to the PMG for resolution (including interaction with the ECMS governance if needed).

In addition, the CRG members agreed to re-discuss in the January 2022 meeting the requirements of CR-580, in particular to clarify the rationale for the 'Negative' business value allocated to this CR by some CRG members.

AP-4036 (ECB Team to organise a dedicated workshop on CR-768 and message customization principles in T2S): The CRG took note that the workshop was held on 06 October and agreed to close the action point.

# T2S – Publication of CoCo usage guidelines on MyStandards

The CRG members took note of the presentation and to avoid duplication, preferred that 4CB publish Common Components usage guidelines only in the "Common components" group of MyStandards, and not in the "T2S" group anymore. The same timeline should be followed as for the inclusion of T2S-relevant functionalities in the common components' UDFS and UHB (and their removal from the T2S UDFS and UHB).

# HSG consultation of the T2S governance: changing T2S Standard 4 - tax info

The CRG members took note of the presentation and confirmed that from a functional perspective, no negative effect is expected to result from the envisaged modification of the T2S standard 4, whereby the rule stating that T2S messages should not contain tax information would be removed.

# Update on ISO customization

CRG members took note that the participants in the workshop on 6<sup>th</sup> October 2021 considered that the customisation of securities-related ISO20022 messages should be handled as a harmonisation topic, since in the absence of harmonisation, an actor active on several markets might need to follow different message specifications depending on the intermediaries it interacts with – even if these intermediaries are connected to the same market infrastructure, i.e. T2S.

CRG members had no additional comments on the outcome of the workshop and agreed with the conclusion to raise this topic in the AMI-SeCo, for AMI-SeCo members to assess the relevance of a harmonisation activity in this area.
