Some CSDs raised concerns about the increase in costs of CR-767 and requested further information on the cost drivers. More detailed information on the costs will be shared with the CSG ii) the CR-722 (NRO) scoping into R6.0 will be initiated with associated GUI related PBIs and iii) the PMG will have a discussion on the increased risk of not having the NRO ready in R6.0 The CSG took note that regarding R7.0 and the inclusion of MS Edge as supported browser, i) the related T2S detailed assessment of CR-769 cannot be completed as required according to the OGPF due to the non-availability of resources for a cross-service impact assessment from T2 and other TARGET Services, ii) some CSDs also will use the GUI of T2 and ECMS and it is therefore preferable that all TARGET Services implement the MS Edge browser at the
