## 3. Peculiarities

It is worth noting that as of this release, as reported in the TIPS-0052 and announced to the TSWG-TIPS and the TIPS CG, the TIPS messages will be available into a dedicated section in MyStandards. The customers have to subscribe to the "CG-TIPS community" to have access to the Usage Guidelines.

The subscription is automatically accepted by the system.

The TIPS UDFS have been enriched so that, for each XML message, the user is redirected via a dedicated URL to the corresponding repository in MyStandards.

Furthermore, the TIPS Actors can access the Readiness Portal by using the following community:

ReadinessPortal-TIPS-Community

An exception to the above described behaviour remains for the camt.006 message and for the TIPS Directory (full and delta) in flat-file format. For those messages, the usual zip file is transmitted for publication on the ECB website.

Due to the lack of confirmation from the EPC regarding the use of Original Message Name Identification for the scenario of pacs.028 relating to pacs.008, the full scope of CR-0056 will be integrated in the final version of the R2023.NOV SDDs, together with the feedback to the market comments.
