CONSOLIDATED FINANCIAL STATEMENT OF THE EUROSYSTEM as at 18 August 2000

I. Items not related to monetary policy operations

In the week ending 18 August 2000 the net position of the Eurosystem in foreign currency (asset items 2 and 3 minus liability items 6, 7 and 8) increased by EUR 0.5 billion to EUR 261.1 billion.

The holdings by the Eurosystem of marketable **securities of euro area residents denominated in euro** (asset item 6) remained virtually unchanged at EUR 25.5 billion. **Banknotes in circulation** (liability item 1) decreased by EUR 3.6 billion to EUR 358 billion. **Liabilities to general government** (liability item 4.1) increased by EUR 2.6 billion to EUR 47.2 billion.

II. Items related to monetary policy operations

The Eurosystem's net lending to its counterparties in the financial sector (asset item 5 minus liability items 2.2, 2.3, 2.4, 2.5 and 3) increased by EUR 9.1 billion to EUR 213.7 billion. On Wednesday, 16 August 2000 a **main refinancing operation** of EUR 45 billion matured and a new one of EUR 54 billion was settled.

Recourse to the **marginal lending facility** (asset item 5.5) remained insignificant, while recourse to the **deposit facility** (liability item 2.2) was EUR 0.1 billion (compared with EUR 0.2 billion in the preceding week).

III. Current accounts of the euro area financial sector

As a result of all transactions, the **current account** position of counterparties with the Eurosystem (liability item 2.1) increased by EUR 9.6 billion to EUR 116 billion.
