# CONSOLIDATED FINANCIAL STATEMENT OF THE EUROSYSTEM as at 6 July 2001

### I. Items not related to monetary policy operations

In the week ending 6 July 2001 the net position of the Eurosystem in foreign currency (asset items 2 and 3 minus liability items 7, 8 and 9) increased by EUR 0.2 billion to EUR 273.7 billion on account of customer and portfolio transactions.

The holdings by the Eurosystem of marketable securities of euro area residents denominated in euro (asset item 7) rose by EUR 0.4 billion to EUR 28.1 billion. Banknotes in circulation (liability item 1) increased by EUR 3.4 billion to EUR 353.6 billion. Liabilities to general government (liability item 5.1) decreased by EUR 25 billion to EUR 38.9 billion.

#### II. Items related to monetary policy operations

The Eurosystem's net lending to credit institutions (asset item 5 minus liability items 2.2, 2.3, 2.4, 2.5 and 4) decreased by EUR 9.9 billion to EUR 222.2 billion. On Wednesday, 4 July 2001, a main refinancing operation of EUR 91 billion matured, while a new main refinancing operation of EUR 81 billion was settled.

Recourse to the **marginal lending facility** (asset item 5.5) was EUR 0.2 billion which was approximately the same as in the preceding week, while recourse to the **deposit facility** (liability item 2.2) was EUR 0.1 billion (compared with EUR 0.3 billion in the previous week).

#### III. Current accounts of euro area credit institutions

As a result of all transactions, the **current account** position of credit institutions with the Eurosystem (liability item 2.1) increased by EUR 15 billion to EUR 132.6 billion.
