# CONSOLIDATED FINANCIAL STATEMENT OF THE EUROSYSTEM as at 22 March 2002

### I. Items not related to monetary policy operations

In the week ending 22 March 2002 the decrease of EUR 55 million **in gold and gold receivables** (asset item 1) corresponded to a sale of 5.1 tonnes by a national central bank of the Eurosystem for the purpose of issuing commemorative gold euro coins. The disposal is consistent with the Central Bank Gold Agreement of 26 September 1999. The net position of the Eurosystem in foreign currency (asset items 2 and 3 minus liability items 7, 8 and 9) decreased by EUR 0.3 billion to EUR 259.4 billion on account of customer and portfolio transactions.

The holdings by the Eurosystem of marketable **securities of euro area residents denominated in euro** (asset item 7) decreased by EUR 0.1 billion to EUR 29.3 billion. **Banknotes in circulation** (liability item 1) decreased by EUR 1.5 billion to EUR 280.2 billion. **Liabilities to general government** (liability item 5.1) increased by EUR 4.3 billion to EUR 51.4 billion.

## **II. Items related to monetary policy operations**

The Eurosystem's net lending to credit institutions (asset item 5 minus liability items 2.2, 2.3, 2.4, 2.5 and 4) increased by EUR 1.8 billion to EUR 166.8 billion. On Monday, 18 March 2002, a **main refinancing operation** of EUR 67 billion matured, while a new one of EUR 69 billion was settled.

Recourse to the **marginal lending facility** (asset item 5.5) was EUR 0.5 billion (compared with virtually nil in the preceding week). Recourse to the **deposit facility** (liability item 2.2) was EUR 0.8 billion (compared with EUR 0.1 billion in the previous week).

## **III. Current accounts of euro area credit institutions**

As a result of all transactions, the **current account** position of credit institutions with the Eurosystem (liability item 2.1) decreased by EUR 1.1 billion to EUR 133.1 billion.
