CONSOLIDATED FINANCIAL STATEMENT OF THE EUROSYSTEM as at 27 June 2003

I. Items not related to monetary policy operations

In the week ending 27 June 2003 the net position of the Eurosystem in foreign currency (asset items 2 and 3 minus liability items 7, 8 and 9) decreased by EUR 0.2 billion to EUR 206.8 billion on account of customer and portfolio transactions.

The holdings by the Eurosystem of marketable **securities of euro area residents denominated in euro** (asset item 7) increased by EUR 0.3 billion to EUR 44.1 billion. **Banknotes in circulation** (liability item 1) rose by EUR 1.3 billion to EUR 377.2 billion. **Liabilities to general government** (liability item 5.1) increased by EUR 24.8 billion to EUR 67.7 billion.

II. Items related to monetary policy operations

The Eurosystem's net lending to credit institutions (asset item 5 minus liability items 2.2, 2.3, 2.4, 2.5 and 4) increased by EUR 20.1 billion to EUR 255.8 billion. On Wednesday, 25 June 2003, a **main refinancing operation** of EUR 129 billion matured and a new one of EUR 150 billion was settled. On Thursday, 26 June 2003, a **longer-term refinancing operation** of EUR 15 billion matured and a new one of EUR 15 billion was settled.

Recourse to the **marginal lending facility** (asset item 5.5) was EUR 0.8 billion (compared with EUR 1.9 billion in the previous week), while recourse to the **deposit facility** (liability item 2.2) was EUR 0.1 billion (compared with EUR 0.3 billion in the preceding week).

III. Current accounts of euro area credit institutions

As a result of all transactions, the **current account** position of credit institutions with the Eurosystem (liability item 2.1) decreased by EUR 3.2 billion to EUR 130.9 billion.
