CONSOLIDATED FINANCIAL STATEMENT OF THE EUROSYSTEM as at 16 April 2004

I. Items not related to monetary policy operations

In the week ending 16 April 2004 the net position of the Eurosystem in foreign currency (asset items 2 and 3 minus liability items 7, 8 and 9) increased by EUR 0.6 billion to EUR 173.6 billion on account of customer and portfolio transactions.

The holdings by the Eurosystem of marketable securities of euro area residents denominated in euro (asset item 7) rose by EUR 0.2 billion to EUR 70 billion. Banknotes in circulation (liability item 1) decreased by EUR 5.6 billion to EUR 435.8 billion. Liabilities to general government (liability item 5.1) fell by EUR 7.3 billion to EUR 38.3 billion.

II. Items related to monetary policy operations

The Eurosystem's net lending to credit institutions (asset item 5 minus liability items 2.2, 2.3, 2.4, 2.5 and 4) decreased by EUR 13 billion to EUR 279.4 billion. On Wednesday, 14 April 2004, a main refinancing operation of EUR 218.5 billion matured and a new one of EUR 205.5 billion was settled.

Recourse to the **marginal lending facility** (asset item 5.5) was virtually nil (approximately the same as in the previous week), and recourse to the **deposit facility** (liability item 2.2) was also virtually nil (compared with EUR 0.1 billion in the previous week).

III. Current accounts of euro area credit institutions

As a result of all transactions, the **current account** position of credit institutions with the Eurosystem (liability item 2.1) increased by EUR 0.2 billion to EUR 135.2 billion.
