Delivery of the T2S UDFS v5.2, UHB v5.2, GFS v5.2 and DMT v1.2.12 and URD v8.2

As envisaged in the T2S Plan, we have published final versions of the:

- T2S User Detailed Functional Specifications v5.2 (UDFS v5.2)
- User Handbook v5.2 (UHB v5.2)
- General Functional Specifications v5.2 (GFS v5.2)
- Data Migration Tool File Format Specifications v1.2.12 (DMT v1.2.12).
- T2S User Requirements Document v8.2 (URD v8.2)

The draft intermediate versions of these documents were published on 6 July 2020 and were reviewed from 7 July 2020 to 24 July 2020. The comments from the market participants have been taken into account for the final versions published on 7 August 2020.

Scope of the delivery

These new versions incorporate Change Requests in the scope of the T2S Release 4.2, including the editorial Change Requests approved by the CSD Steering Group (CSG) until 26 May 2020.

The exhaustive list of all Change Requests is provided as Annex A to this cover note.

Complementing the information provided in the Service Transition Plans, the Release Notes and the UDFS itself, a list containing all the T2S messages with their respective links to MyStandards is provided as Annex B to the Cover Note.
